#### ITEM #6 Comments on the agenda

*Mark Reynolds asked if there is any more information regarding Bayside. Supervisor Osborn said that there is nothing more at this time the next meeting with Bayside is on Thursday.*

*Ben Trapani asked if he could have public comment at this time to speak about the playground.*

*The Board agreed to allow public comment regarding the playground.*

Mr. Trapani said he heard that the playground is being moved to the Town Park and asked what the problem is with it being at 21 Milton Turnpike.

*Supervisor Osborn said that the Board hasn't determined which park yet and the main reason is safety concerns.*

Mr. Trapani explained an incident regarding a man verbally harassing his son's caregiver at the Cluett Schantz Park which he reported to the police. He said that others have told him they were harassed by the same man as well. He is concerned about people's safety and would like the man removed from the park.

*Some of the Board members said they are aware that this man is verbally harassing people. The Board discussed this situation with Chief Cocozza.*

*Supervisor Osborn said that he can check with State Parks to see if there is anything that can be done. There was a disagreement about calling State Parks.*

Chief said the only formal complaint is the one mentioned above. He will check with the DA and explain the situation and the complaints to see what actions can be taken.

*Julie Amodeo said her grandson uses the playground at 21 Milton Turnpike and she feels safe there and doesn't feel safe at the Town Park.*

*Some of the Board members and Chief Coccozza reiterated from the last Town Board meeting the safety reasons for moving the playground.*

James Santora said that he would rather have his grandchildren play on the playground at 21 Milton Turnpike and just have it moved south on the property because the police are here or move it to the Sands Avenue Park. He said people feel safer here.

*A few other residents commented on why they would like the playground to stay at the current location or moved to the south of the property.*

*Anthony Amodeo said he and his caregiver alternate bringing his grandson to the playground for three years now and there has never been any problems. He feels that it is a safe environment and if something were to happen the police are right there.*

*Councilman Corcoran again said that they are moving the playground for no other reason but safety.*

*Julie Amodeo asked the Board if the petition was taken into consideration before voting on moving the playground at the last meeting.*

*Supervisor Osborn said yes they did and Councilman Baker said that not one of the people who signed the petition were at that meeting.*

*Councilman Molinelli made a motion to look into what it would cost to lease the property from the school to move the playground to the south end of the property at 21 Milton Turnpike. Motion seconded by Councilman Koenig.*

D) HIGHWAY SUPERINTENDENT – GAEL APPLER, SR.

**Monthly Report for April 2015**

**ROADS:** On 4/7 we started street sweeping, gutter sweeping and cleaning out ditch lines as part of our spring clean up. We also did lawn repairs and sign inspections, replacing or repairing them when necessary. For a week we did crack sealing throughout the Town. On 4/16 we removed the stumps that remained after taking down trees last month.

**DRAINAGE:** On 4/14 we rebuilt a c.b. on Main Street, Milton. On 4/29 we installed a weeper at a stone wall on Orange St.

**MAINTENANCE:** We spent one week pulling off and servicing our sanders for summer storage. We also pulled off plow hoists, reinstalled the tarps, put on tailgates and gravel pans so the trucks are ready for summer.

**TOWN PARK:** On 4/16 we also removed tree stumps around the new pavilion. We finished landscaping at the Park, hauling dirt from the Landfill, seeding and applying straw.

**LANDFILL:** On 4/24 we also did a spring clean up.

**WATER DEPARTMENT:** On 4/1 we assisted the WD with a water main break on Church Street and Hudson Terrace. On 4/8 we repaired a service line on Church Street.

Al Lanzetta asked for clarification on who was going to speak to Central Hudson regarding the LED lights.

Councilman Corcoran said the CAC began researching the lighting project, then the Central Hudson representative was in contact with the Board for various reasons. He doesn't think that the CAC will need to continue to work on the lighting.

Supervisor Osborn added that the Board and CAC can think of a new project.

Al Lanzetta said the Rosendale CAC did an extensive report which saved that Town thousands of dollars and they looked for lights that were out and be replaced with LED and also looked to see if lights could be decommissioned.

Supervisor Osborn said the CAC and the Board will be doing different things to improve the lighting districts. The CAC can continue with seeing which lights we need and do not need and the Board will continue with Central Hudson and the LED lighting.

Councilman Baker said that he has a second estimate from two of the website companies and should have a recommendation soon.

Glen Botto thanked the Board for their support at the last meeting regarding the Train Station Roof. The Foundation has a meeting in a week and the person who runs the meeting would like information regarding the roof, like what the process will be and the dates. He also asked when they get any information if someone would contact him.

Councilman Corcoran said that Yankee Construction has to get their bonds in place and order material so it will probably be about a month.

Mr. Botto also said the Wallkill Valley Land Trust Historic House Tour will be on May 30, 2015 and will begin at the Train Station so he wanted to let the Board know they may have about 300 people at the station.

Councilman Corcoran said the exterior of the Train Station has lead and the Town has a lead report. He asked the Board if they wanted to get an engineer to look at it to see if they enclose the exterior or if it needs to be replaced.

The Board was okay with Councilman Corcoran calling McGoe, Hauser, and Edsall to get a quote for them to look at the siding to see what can be done.

Supervisor Osborn said that he and Mr. Botto applied for a \$5,000.00 grant for fencing which had to go through a 501C3 so the Train Station helped. The fencing will be an extension of the existing fence at the Train Station. There is still money left from another grant that can be used for safety improvements. Barton and Loguidice is looking to get another \$25,000.00. The grants would total about \$80,000.00 which will help with the safety improvements. The Department of State grant is no longer possible because they are putting money toward the commuter rail accidents, therefore, the safety improvements will be done on a smaller scale.

*Supervisor Osborn read the following letter from Kim Pomeroy, Camp Director requesting to purchase two way radios for the camp:*

I am requesting your approval to purchase new two way radios (walkie-talkies) for our Camp personnel. These radios are used daily to allow our counselors instant communication with our supervising staff and among themselves. The radios are essential for our park operation and during our field trips to the pool and the Ulster County Fair.

As you may know, several of the existing radios experienced charging problems last season. All of the Midland brand radios failed to charge, and an experienced technician has suggested replacement of the batteries with new ones. However, he was unable to explain why the radios failed to charge new test batteries, leading us to conclude that the radios themselves are possibly defective. The Midland radios can no longer be relied upon for our daily operation. The remaining radios are much older and in various stages of degradation.

We have researched vendors with which the Town has an established account and find that Office Depot carries the following radio:

**Uniden GMR4040-2CKHS 40-mile 2-way radio.** Each set contains: Two Weather Resistant 40 Mile Range FRS/GMRS Radios with 2 Vox Headsets; 2 x NiMH Battery Packs; Charging Cradle; 2 x Carabiner Clips; 2 x Belt Clips.

The cost is \$81.99 per set (two radios).

I would like to purchase eight (8) sets totaling \$655.92.
