ITEM # 8 New Business

A). 2018 Camp Salaries

Councilman Corcoran stated that the camp counselors were being paid \$4.06 per hour; they are raising the pay for camp counselors as follows:

Youth Counselors - \$10.00 per hour

Senior Counselors - \$10.50 per hour

Adult Counselors - \$11.00 per hour

The Board is also going to raise the cost of camp from \$95.00 to \$125.00 per week to offset the raises.

Councilman Koenig made a motion to raise the pay for camp counselors from \$4.06 to Youth Counselors - \$10.00 per hour, Senior Counselors - \$10.50 per hour, and Adult Counselors - \$11.00 per hour. Motion seconded by Councilman Molinelli.

ITEM #9 Workshop topics

A). Rec Center

Councilman Corcoran stated that Donald A. Deluca of Glenmont is looking to purchase the TOMVAC building to run a sprinkler system installation and manufacturing company. Mr. Deluca would like to add a 3,000 square foot addition for offices and storage. Councilman Corcoran asked the Board for permission to send the offer to Ron Blass to make sure everything is correct with the proposal and get a resolution made up.

Councilman Molinelli made a motion to send Donald A. Deluca's proposal to purchase the TOMVAC building to Town Attorney, Ron Blass for review and have a resolution drawn up. Motion seconded by Councilman Koenig.

Councilman Corcoran stated that there was a meeting with Mr. Pizza from the Hudson Valley Sports Dome to discuss using the building in front of the dome for a recreation/community center.
