ITEM #6 Presentations

A). President of the Lions Club Steve Jennison- Senior Picnic

Steve Jennison, President of the Marlboro/Milton Lions Club, stated that the club committee met. They would like to decide by July 15th whether or not they will hold the senior picnic (lunch only) at the town park on August 13th with modified seating and serving or serve food from the concession building at Marlboro High School.

The majority of the Board discussed with Mr. Jennison in more detail about what type of food will be served and how it will be served. Either way the plan is to also provide home delivery for the homebound seniors and the seniors who are uncomfortable going out.

B). Chief Cocozza-Executive order # 203 New York State Police Reform and Reinvention Collaborative

Chief Cocozza stated that New York State police departments are being mandated to review and revise their rules, regulations and policies and procedures. They will need to put together a committee of police including himself, the Chief, and the union. They will need members of the community as well from not for profit organizations, faith based groups, the public defender's office, the district attorney's office, and local elected officials. There are over 300 pages of rules and regulations to look over. Currently, the department rule book is from an accredited agency. If there are any changes, they will need to be voted on by the town and adopted by resolution or local law. Then all documents are to be sent to NYS Director of Budgets by April 1, 2021.

ITEM #8 New Business

A) Transfer Station Hours

The Board had a brief discussion and decided to keep the hours at the Transfer Station the same (Saturday only) until further notice.

The Transfer Station will also be open on Friday, July 3rd from 8:00 a.m. to 3:00 p.m. instead of Saturday because of the holiday.

They also discussed the removal of tires and brush with the shortfall in the budget.

ITEM #9 Workshop topics

A). COVID-19

Tom Corcoran stated that Phase 3 is taking place on June 23, 2020. Restaurants can open at 50% capacity and groups of 25 can gather.

There was a discussion about whether or not to reopen the park for rentals and bocce and if so what kind of rules would be in place. The Board decided to plan to open bocce,

pavilion and Train Station rentals, and resume Zumba indoors after Phase 4 as long as reopening goes as planned.

B). Christian Hill Trail

C). Water Tank on Western Ave.

Supervisor Lanzetta stated that Dennis Larios suggested decommissioning the water tank. The majority of the Board gave their opinions and discussed what they would like to do about the water tank. It was decided that they would hold off doing anything this year for budgetary reasons and continue talking with Mr. Larios about the concerns the Board has.
