*Supervisor Lanzetta opened the public hearing for comments.*

*Eric Stralow, resident and farm owner, explained how being an Air B & B and VRBO host personally have been a help financially. He described some statistics and also struggles he and his wife have had. He thanked all who worked on the Short-Term Rental law.*

*Bridgette Supernova made multiple suggestions about the law with regard to: Definitions, the maximum capacity rule, the length of stay, applicants, residency, hours of operation, adjoining properties, and fees. Ms. Supernova's suggestions were to be less restrictive with regard to some of the rules and also fees. Supervisor Lanzetta asked Ms. Supernova to email her questions and comments to him.*

*Some of the Board members explained that they are still discussing the fees; they chose to only allow dwellings to make sure this doesn't get out of control.  
There was a brief discussion about renters and neighbors and also about fees.*

*Ronald Tatelbaum stated that the law will need to protect the neighbors. He and his wife, Shelley had problems in the past with noise from a rental near them and they expressed some of their concerns and gave suggestions. Mr. Tatelbaum also asked how the three strikes in the law will be policed.*

*Supervisor Lanzetta explained that with the minor site plan the neighbors would be notified by the homeowner of the intention to have a rental. There is another item in the law that states there is a three strikes you're out rule and after the third strike the certificate will not be renewed by the town.*

*The majority of the Board and Chief Cocozza explained how the new law will work with regard to notification and policing and penalties for offenses such as noise complaints.*

*James Garofalo commented that neighbors will know who the applicant is and should be able to get their contact information. He also recited pieces of local legislation with regard to site plan boundaries and suggested that applicants should include an ariel view of their property by going on Ulster County Parcel Viewer.*

*The public hearing will remain open.*
