ITEM #6 Supervisor Updates
Supervisor Corcoran presented the main criteria that the firefighters exemption law states which is incorporated into the minutes as follows:

- *10% exemption from taxation of the assessed value of the volunteer's personal property*
- *The enrolled member/applicant of the volunteer fire company or fire department resides within the Town of Marlborough*
- *The real property is the primary residence of the enrolled member/applicant*
- *The real property is used exclusively for residential purposes*
- *The enrolled member/applicant has been certified by the authority having jurisdiction of the volunteer fire company or fire department*
- *The enrolled member of such company or department served a minimum of (2) two consecutive years of service*
- *Such governing authority shall certify eligibility for the exemption utilizing the official service records of each enrolled member/applicant*
- *Lifetime exemption for members with more than (20) twenty years of active service*
- *Un-remarried spouses of volunteer killed in the line of duty shall be entitled to continue the partial exemption as long as such deceased volunteer firefighter had been an enrolled member of volunteer fire company or fire department for at least (5) five years*
- *Un-remarried spouses of deceased volunteer firefighters such deceased volunteer firefighter had been an enrolled member of a volunteer fire company or fire department*
- *A volunteer firefighter must annually, on or before the applicable taxable status date, file an application for such property tax exemption with the assessor responsible for preparing the assessment roll*

Supervisor Corcoran also stated that all building projects are moving forward. He again thanked Rosemary Wein for all her help with grants. He thanked Tom Corcoran for helping out with the application for a \$125,000.00 parks and recreation grant through the county.

ITEM #8 Comments on the agenda

Tom Coupart thanked the Board on behalf of the Marlboro Hose Company for the opportunity to apply for the firefighter exemption.

Councilman Molinelli and Supervisor Corcoran, on behalf of the Board, thanked the firefighters for all their service to the community. Supervisor Corcoran thanked Gael Appler Jr. for all the research he did with regard to the exemption.

At this time, Maribeth King asked to present a fundraiser idea for the Sarah Hull Hallock Free Library to the Board and public.

Ms. King handed out a brochure and explained the history of the building. She stated that the library is in need of some construction. They have received some grants, thanks to Rosemary Wein but they need more funds. The annex will become the children's area with age-appropriate furniture and will be ADA compliant. The current children's section will become the adult section. The bricks will be laid in the alcove at the entrance. There is room for 1000 customized bricks that can be personalized and engraved. Ms. King explained the pricing, sizes and how to order; she encouraged the Board to purchase a brick. She stated that all the work will be done by local people. Steve Riviuccio will lay the bricks, Gael Appler, Jr. will do some construction, Dave Pulliam will do the electric and Mike Charter will paint. She thanked the Board for letting her present and also for allowing her space in Town Hall to display the information.

B). Resolution # 37 To adopt Local Law#1 of the year 2023 providing for partial exemption from taxation of certain real property owned by an enrolled member of an incorporated volunteer fire company or fire department serving the Town of Marlborough pursuant to section 466-a of the real property tax law.

Supervisor Corcoran proposes the following:

WHEREAS, a local law was introduced to be known as Local Law No. 1 of 2023, entitled LOCAL LAW NO. 1 OF 2023 A LOCAL LAW PROVIDING FOR PARTIAL EXEMPTION FROM TAXATION OF CERTAIN REAL PROPERTY OWNED BY AN ENROLLED MEMBER OF AN INCORPORATED VOLUNTEER FIRE COMPANY OR FIRE DEPARTMENT SERVING THE TOWN OF MARLBOROUGH PURSUANT TO SECTION 466-a OF THE REAL PROPERTY TAX LAW.

WHEREAS, a public hearing in relation to said local law was held on February 27, 2023, at 7:00 p.m., prevailing time; and

WHEREAS, notice of said public hearing was given pursuant to the terms and provisions of the Municipal Home Rule Law of the State of New York; and

WHEREAS, said local law has been on the desks of the members of the Town Board of the Town of Marlborough for at least seven (7) days, exclusive of Sunday;

NOW, THEREFORE, BE IT RESOLVED that the following local law is hereby enacted:

Section 1. Purpose.

This Local Law is enacted for the purpose of exempting from taxation certain real property owned by an enrolled member of an incorporated volunteer fire company or fire department which serves the Town of Marlborough to the extent of ten percent (10%) of the assessed value of such real property, as authorized by Section 466-a of Real Property Tax Law of the State of New York.

Section 2. Amendment.

The Town of Marlborough Code entitled **Chapter 137. TAXATION** shall be and hereby is amended by this Local Law by the addition of a new Article IV Exemption for Volunteer Firefighters, which shall read in its entirety as follows:

Article IV Tax Exemption for Volunteer Firefighters

§ 137-18. Legislative Intent.

The purpose of this Article is to provide a partial exemption from taxation imposed by the Town of Marlborough upon real property situated within the Town of Marlborough owned by persons who voluntarily serve as members of an incorporated volunteer fire company or fire department serving the Town of Marlborough (a “Volunteer Fire Company or Fire Department”) subject to the provisions set forth herein, pursuant to the authority granted to the Town by § 466-a of the Real Property Tax Law of the State of New York.

§ 137-19. Partial Exemption Granted.

- A. Real property within the Town of Marlborough owned by an enrolled volunteer member of a Volunteer Fire Company or Fire Department or by such enrolled member and his or her spouse shall be exempt from taxation to the extent of ten percent (10%) of the assessed value of such property for Town and Special District purposes, exclusive of special assessments, Water District, Water Improvement Area, Sewer District and Sewer Improvement Area ad valorem levies, and assessments for capital improvements, subject to the following requirements.
- B. Such exemption shall not be granted unless:
 - 1. The enrolled member/applicant of the Volunteer Fire Company or Fire Department resides within the Town of Marlborough;
 - 2. The real property is the primary residence of the enrolled member/applicant;
 - 3. The real property is used exclusively for residential purposes; provided however, that in the event any portion of such real property is not used exclusively for the enrolled member/applicant’s residence but is used for other purposes, such portion shall be subject to taxation and the remaining portion used for residential purposes shall be entitled to the exemption provided by this Article; and
 - 4. The enrolled member/applicant has been certified by the authority having jurisdiction of the Volunteer Fire Company or Fire Department (the “Governing

Authority”) as an enrolled member of such Company or Department having served a minimum of (2) two consecutive years of service. Such Governing Authority shall certify eligibility for the exemption utilizing the official service records of each enrolled member/applicant.

§ 137-20. Lifetime Partial Exemption Eligibility.

Eligible real property owned by an enrolled member of the Volunteer Fire Company or Fire Department who accrues more than (20) twenty years of active service and whose enrollment is so certified by the applicable Governing Authority of the Volunteer Fire Company or Fire Department shall be granted the ten percent (10%) exemption as authorized by this Article for the remainder of the enrolled member’s life as long as such real property remains his or her primary residence in the Town of Marlborough.

§ 137-21. Line of Duty Death Partial Exemption Eligibility.

Un-remarried spouses of volunteer firefighters from the Volunteer Fire Company or Fire Department killed in the line of duty shall be entitled to continue the partial exemption granted hereunder; provided, however, that:

1. Such un-remarried spouse is certified by the Governing Authority as an un-remarried spouse of an enrolled member of the Volunteer Fire Company or Fire Department who was killed in the line of duty when so enrolled; and
2. such deceased volunteer firefighter had been an enrolled member of Volunteer Fire Company or Fire Department for at least (5) five years; and
3. the eligible real property owned by such deceased volunteer firefighter at the time of his or her death had been receiving the exemption prior to his or her death.

§ 137-22. Deceased Member Partial Exemption Eligibility.

Eligible real property owned by un-remarried spouses of deceased volunteer firefighters of a Volunteer Fire Company or Fire Department shall be entitled to continuation of the partial exemption granted hereunder, provided, however, that:

1. Such un-remarried spouse is certified by the Governing Authority as an un-remarried spouse of a person who was an enrolled volunteer member of a Volunteer Fire Company or Fire Department at the time of his or her death; and

2. such deceased volunteer firefighter had been an enrolled member of a Volunteer Fire Company or Fire Department for at least (20) twenty years; and
3. the eligible real property benefited from the partial exemption prior to his or her death.

§ 137-23. Application Procedure.

A volunteer firefighter must annually, on or before the applicable taxable status date, file an application for such property tax exemption with the assessor responsible for preparing the assessment roll for the Town of Marlborough on a form as prescribed by the New York State Commissioner of Taxation and Finance.

Section 3. Severability

The invalidity or unenforceability of any section, subsection, paragraph, sentence, clause, provision, or phrase of this Local Law, as declared by the valid judgment of any court of competent jurisdiction to be unconstitutional, shall not affect the validity or enforceability of any other section, subsection, paragraph, sentence, clause, provision, or phrase of this Local Law, which shall remain in full force and effect.

Section 4. Repeal

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

Section 5. Authority

This Local Law is enacted pursuant to the Municipal Home Rule Law and Real Property Tax Law §466-a. This Local Law shall supersede the provisions of Town Law to the extent it is inconsistent with the same, and to the extent permitted by the New York State Constitution, the Municipal Home Rule Law, or any other applicable statute.

Section 6. Effective Date

This law shall become effective upon filing with the office of the New York State Secretary of State in accordance with the Municipal Home Rule Law.

RESOLVED that the Town Clerk shall file a certified original of this local law in the office of the Town Clerk and one (1) certified copy in the Office of the Secretary of State, State of New York, such certified copy to have attached thereto a certificate that it contains the correct text of the enactment of this local law.

C). Resolution # 38 To introduce a Local Law of the year 2023

Supervisor Corcoran proposes the following:

A LOCAL LAW OF THE TOWN OF MARLBOROUGH, ULSTER COUNTY, NEW YORK,
AMENDING CHAPTER 67 “BUILDING CONSTRUCTION” ARTICLE I
“ADMINISTRATION AND ENFORCEMENT” SECTION THREE “CODE ENFORCEMENT
OFFICER; INSPECTORS,” GRANTING THE CODE ENFORCEMENT OFFICER THE
AUTHORITY TO ISSUE SUMMONSES FOR PARKING OFFENSES AS DEFINED UNDER
CHAPTER 145 OF THE TOWN CODE

BE IT ENACTED by the Town Board of the Town of Marlborough, that the Town Code
is amended to read as follows:

Section 1. Purpose

This Local Law is enacted for the purpose of amending the code to provide the Code
Enforcement Officer with the authority to issue summonses for parking offenses as defined under
Chapter 145 of the Town Code.

Section 2. Amendment.

The Town of Marlborough Code entitled Chapter 67 BUILDING CONSTRUCTION,
Article I ADMINISTRATION AND ENFORCEMENT, Section Three, CODE ENFORCEMENT
OFFICER; INSPECTORS shall be and hereby is amended by this Local Law, which shall read in
its entirety as follows:

Article I Administration and Enforcement

§ 67-3 Code Enforcement Officer; Inspectors.

A. The office of Code Enforcement Officer is hereby created. The Code Enforcement
Officer shall administer and enforce all the provisions of the Uniform Code, the Energy
Code and this article. The Code Enforcement Officer shall have the following powers and
duties:

(1) To receive, review and approve or disapprove applications for building permits,
certificates of occupancy, certificates of compliance, temporary certificates and
operating permits, and the plans, specifications and construction documents
submitted with such applications;

(2) Upon approval of such applications, to issue building permits, certificates of
occupancy, certificates of compliance, temporary certificates and operating
permits, and to include in building permits, certificates of occupancy, certificates

of compliance, temporary certificates and operating permits such terms and conditions as the Code Enforcement Officer may determine to be appropriate;

(3) To conduct construction inspections, inspections to be made prior to the issuance of certificates of occupancy, certificates of compliance, temporary certificates and operating permits, fire safety and property maintenance inspections, inspections incidental to the investigation of complaints and all other inspections required or permitted under any provision of this article;

(4) To issue stop-work orders;

(5) To review and investigate complaints;

(6) To issue orders pursuant to § 67-15A, Compliance orders, of this article;

(7) To maintain records;

(8) To collect fees as set by the Town Board of this Town;

(9) To pursue administrative enforcement actions and proceedings;

(10) In consultation with this Town's attorney, to pursue such legal actions and proceedings as may be necessary to enforce the Uniform Code, the Energy Code and this article, or to abate or correct conditions not in compliance with the Uniform Code, the Energy Code or this article;

(11) To exercise all other powers and fulfill all other duties conferred upon the Code Enforcement Officer by this article; and

(12) To issue summonses for parking offenses as defined in § 145-21 of the Town Code.

B. – E. ... no change

Section 3. Severability

The invalidity or unenforceability of any section, subsection, paragraph, sentence, clause, provision, or phrase of this Local Law, as declared by the valid judgment of any court of competent jurisdiction to be unconstitutional, shall not affect the validity or enforceability of any other section, subsection, paragraph, sentence, clause, provision, or phrase of this Local Law, which shall remain in full force and effect.

Section 4. Repeal

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

Section 5. Authority

This Local Law is enacted pursuant to the Municipal Home Rule Law. This Local Law shall supersede the provisions of Town Law to the extent it is inconsistent with the same, and to the extent permitted by the New York State Constitution, the Municipal Home Rule Law, or any other applicable statute.

Section 6. Effective Date

This law shall become effective upon filing with the office of the New York State Secretary of State in accordance with the Municipal Home Rule Law.

D). Resolution # 39 To introduce a Local Law of the year 2023

Supervisor Corcoran proposes the following:

A LOCAL LAW OF THE TOWN OF MARLBOROUGH, ULSTER COUNTY, NEW YORK,
AMENDING CHAPTER 145 “VEHICLES AND TRAFFIC” ARTICLE VIII “PENALTIES”
PROVIDING THE TOWN BOARD WITH THE AUTHORITY TO SET FINES FOR
PARKING OFFENSES THROUGH THE TOWN OF MARLBOROUGH FEE SCHEDULE,
AND TO PROVIDE THE CODE ENFORCEMENT OFFICER WITH THE AUTHORITY TO
ISSUE PARKING SUMMONSES

BE IT ENACTED by the Town Board of the Town of Marlborough, that the Town Code is amended to read as follows:

Section 1. Purpose

This Local Law is enacted for the purpose of amending the penalties listed for parking tickets to provide for the Town Board to have the ability to set these fines through the Town of Marlborough fee schedule. This Local Law also serves the purpose of giving the Code Enforcement Officer the authority to issue Parking Tickets.

Section 2. Amendment.

The Town of Marlborough Code entitled **Chapter 145. VEHICLES AND TRAFFIC, Article VIII PENALTIES** shall be and hereby is amended by this Local Law, which shall read in its entirety as follows:

Article VIII Penalties

§ 145-20 Penalties for offenses. ... no change

§ 145-21 Penalties for parking offenses.

A. Every person accused of a parking offense in violation of the Vehicle and Traffic Law of the State of New York has the option of appearing in Town Court before the presiding Town Justice or may use the mail by filing the official Town of Marlborough traffic summons and remitting the minimum fine set pursuant to ~~this section as follows~~ the Town of Marlborough fee schedule in effect as adopted by the Town Board.

Double parking, blocking driveway, parking overtime, parked against traffic, parked in bus stop, no parking or parked on sidewalk	\$20.00
Parked in fire lane	35.00
Blocking fire hydrant or violation of Snow Ordinance	50.00

~~Parking a vehicle on a public highway that is unregistered or improperly registered displays improper or switched license plates, does not display a valid inspection sticker, obstructs the normal flow of traffic or protrudes into an intersection~~ 20.00

B. Any vehicle that is found in violation of any of the above parking offenses, after been issued a parking ticket for the same, may be towed at the owner's expense, at the direction of any Town of Marlborough Police or ~~traffic officer~~ Code Enforcement Officer.

Section 3. Severability

The invalidity or unenforceability of any section, subsection, paragraph, sentence, clause, provision, or phrase of this Local Law, as declared by the valid judgment of any court of competent jurisdiction to be unconstitutional, shall not affect the validity or enforceability of any other section, subsection, paragraph, sentence, clause, provision, or phrase of this Local Law, which shall remain in full force and effect.

Section 4. Repeal

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

Section 5. Authority

This Local Law is enacted pursuant to the Municipal Home Rule Law. This Local Law shall supersede the provisions of Town Law to the extent it is inconsistent with the same, and to the extent permitted by the New York State Constitution, the Municipal Home Rule Law, or any other applicable statute.

Section 6. Effective Date
