21 the prices on all of our applications. Everything is
22 online. So that's all done right now.

24 applied and in the process is under the old --

3 And then on our site plans from back in 2015
4 to date, I have some things that need to be followed

8 will update it with the new ones, and I'll forward it
9 to you guys tomorrow so you can look at it and see.
10 Do you want the resolutions with that?

11 MS. LANZETTA: The date of the resolution.
12 That will give us an idea of the time clock.

13 MS. FLYNN: Okay. And then, which includes
14 Pat and Meghan in this one, is when we are done with
15 an application, I need, like, the final billing so I
16 know when the application is totally finished because
17 some of them get a refund, then I get another bill.
18 And then they're, like, wait a minute. You just gave
19 me a refund. Why am I getting billed? So I need to
20 know when there is a last bill that's done. And with
21 these, I tried to do what I could do. I don't know.
22 I have some things circled for you. But other than
23 that -- like if they had to mark out a house, I
24 wouldn't know that.

2 Batters/Bakers Tale for a final of the site plan.
