THIS INDENTURE, made the 2nd day of February 2025

WITNESSETH, that the party of the first part, in consideration of Ten Dollars, lawful money of the United States in hand paid by the party of the second part, does hereby grant and release unto the party of the second part, the heirs or successors and assigns of the party of the second part forever,

ALL that certain plot, piece or parcel of land, situate, lying and being in the Town of Marlborough, County of Ulster, State of New York and more particularly described in the Schedule A attached hereto and made a part hereof.

TO HAVE AND TO HOLD the premises herein granted unto Grantee and her heirs, executors, administrators, successors and assigns forever.


Grantor covenants that Grantor has not done or suffered anything whereby said premises have been encumbered in any way whatever, except as set forth herein.



ALL that certain plot, piece or parcel of land, with the buildings and improvements thereon erected, situate, lying and being in the Town of Marlborough, County of Ulster and State of New York, being bounded and described as follows:

BEGINNING at the southeast corner of a lot of land owned formerly by Oliver Covert on the north side of the highway leading from said Village to Lattintown;

RUNNING THENCE easterly along the north side of said highway 116.00 feet to a stake driven in the ground aside of the fence (said stake stands 26.00 feet from the southeast corner of the dwelling house on said lot);

THENCE northerly in a straight line in range with a stake driven in the ground on the South bank of the creek to said pond about 72.00 feet (said course runs about 2.00 feet on the West side of the well curb);

THENCE westerly along the south bounds of said creek or pond about 124.00 feet to said Covert's land;
