ITEM #6 Presentations

A). Noah Fodera- Eagle Scout Project-Sands Ave over look project

Noah Fodera stated that he is in Troop 72 and attends Marlboro High School. He is looking to do his Eagle Scout Project at the Sands Avenue Park. He gave the Board a pamphlet describing his intentions. The project would include clearing part of a trail and adding 2 benches. He may also add a small sign describing the local wildlife.

Amy Hepworth was not in attendance. Supervisor Lanzetta stated that Ms. Hepworth is asking the Department of Transportation for speed control/safety signs on 9W by her farm. She was asked to come to the Town Board for permission first.

C). Pride of Marlborough-Marlboro High School Varsity Baseball/Marlboro High School Varsity Softball

Varsity Head Coach, David Onusko, accepted the Pride of Marlborough Commendation on behalf of the Marlboro High School Varsity Baseball and Marlboro High School Varsity Softball teams. The commendation is to recognize these teams for their New York State Championship wins and great achievements they accomplished this year.

James Garofalo suggested that the Town put up a sign to remember the achievements of the boys and girls varsity teams.

A) Sign Law

Supervisor Lanzetta stated that the Board can try to finish up the sign law in two weeks.

B) Bayside (recreation building)

Councilman Baker stated that the Town met with the Board of the First Presbyterian Church in Marlboro to discuss possibly purchasing a 3 acre lot that the church owns to build a recreation building. The property has water and sewer and could have natural gas. The Town is currently working on getting an appraisal of the property.

Supervisor Lanzetta added that they are looking at this option. They are also looking into the 1.25 acre lot that Bayside will donate and also the TOMVAC building as discussed at prior meetings. They would have a possible \$250,000.00 grant for TOMVAC. He stated that they may be able to forego the cost of \$150,000.00 for the sprinkler system if they limit the number of people in the building to 99. They could use the \$150,000.00 to make other updates.

The majority of the Board expressed their opinions and discussed the pros and cons of each option.

C) 2016 Goals and Objectives

Councilman Baker said the Town is taking care of a lot of the goals and objectives, he is checking them off and will give an update.

Councilman Corcoran stated that the Highway Department has begun demolishing the sidewalks in the Marlboro Hamlet on Church Street and King Street. The sidewalks will be replaced by the Highway Department along with Local 17. The Highway Department will then work on the removal of the fuel tanks and possibly replacing sidewalks in Milton. They also want to get the cement pad poured for the storage building at the park.

Councilman Baker said he hasn't heard back from the gentleman who seemed interested in leasing the building.

E) Bayside Project-Advertise for a special Planning Board and Town Board Meeting

H) Verizon Cell Tower on Milton Water Tank
Supervisor Lanzetta stated that Verizon hasn't come to the Town with an estimate of how much the road would cost for the correct easement. The cell tower will generate about \$20,000.00 for the Town.

I) Milton Train Station Grant-Exterior Rehabilitation
Supervisor Lanzetta stated that the grant application is on track but the state needs supplemental information. Once they get the okay from the finance department, they can begin the process to do the rehabilitation.

ITEM #10 New Business

A) Clean and Decommission Old Fuel Tanks
Supervisor Lanzetta stated that they Board received a letter from Gael Appler. The letter informed the Board of two proposals to clean and decommission the old fuel tanks at 1650 Route 9W, Milton. The proposals are as follows:

Luzon Environmental - \$3,725.00 for the work plus \$1.00 gal for old product in tanks- estimated cost \$5,225.00

American Petroleum - \$6,865.00 – lump sum bid

Councilman Koenig made a motion to accept the lower estimated proposal from Luzon Environmental for \$5,225.00. Motion seconded by Councilman Molinelli.

Mark Reynolds asked for clarification regarding Bayside and if they are getting a tax break for the recreation building they are offering to build.
